3. Purpose of processing

We use the personal data collected from you for the purpose of psychotherapeutic counselling.

4. Basis for collecting and processing your data

You have given us your consent to collect the data for the purpose stated above.

5. Storage period

Your personal data will be stored for the duration of your consultation with the Psychotherapeutic Counseling Center and beyond that for 10 years after the completion of the treatment/counseling (Professional Code of Conduct of the Lower Saxony Chamber of Psychotherapists §9 para. 3).

6. Your rights as a person affected by data processing

You have the right to obtain information from the Studentenwerk OstNiedersachsen about the personal data concerning you. You also have the right to correct, delete or restrict the processing of this data. Furthermore, you can object to the processing of the data and have the right to data portability. If you have provided us with the data on the basis of consent (see point 4), you can revoke this consent at any time without affecting the lawfulness of the processing carried out on the basis of the consent until revocation.

7. Right to complain to a supervisory authority
