#### Purpose of processing

## Your rights as a person affected by data processing

You also have the right to correct, delete or restrict the processing of this data. Furthermore, you can object to the processing of the data and have the right to data portability. If you have provided us with the data on the basis of consent (see point 4), you can revoke this consent at any time without affecting the lawfulness of the processing carried out on the basis of the consent until revocation.
